Consolidated Scrutinizer's report on the results of voting by unsecured creditors of Ref: AMNS Gandhidham Limited ("AMNS Gandhidham") through remote e-voting process (prior to and during the meeting) at the Hon'ble National Company Law Tribunal, Mumbai Bench ("Hon'ble Tribunal" "NCLT") convened meeting of the unsecured creditors of AMNS Gandhidham held on Monday, April 22, 2024 at 12:00 PM (IST) ("Meeting"), through video conferencing/other audio visual means ("VC/OAVM"), pursuant to Sections 230-232 of the Companies Act, 2013 ("Act") read with the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016 ("Rules") and other applicable provisions of the Act.

Meeting of the Unsecured Creditors of AMNS Gandhidham Sub:

Sir,

We, M/s S P Sakhala & Co, Practicing Chartered Accountants, have been appointed by the NCLT, by its order dated February 23, 2024 in Company Application No. (CAA) 5 (MB) of 2024 as rectified by the order dated March 13, 2024 in Company Application No. 64/ MB/ 2024 in Company Application No. (CAA) 5 (MB) of 2024 (together, the "Order"), as the Scrutinizer for the purpose of scrutinizing the remote e-voting process (prior to and during the meeting), of the meeting of the unsecured creditors of AMNS Gandhidham convened by the said Order on Monday, April 22, 2024 at 12:00 PM (IST) through VC/OAVM, pursuant to the provisions of the 230 to 232 of the Act read with the Rules and other applicable provisions of the Act, on the below mentioned resolution seeking approval of the unsecured creditors on the scheme of amalgamation and arrangement among AMNS Gandhidham, ArcelorMittal Nippon Steel India Limited and their respective shareholders ("Scheme").

We do hereby submit our report as under:

- AMNS Gandhidham had provided its unsecured creditors the facility to exercise their right to vote on the resolution proposed to be considered at the Meeting through electronic means (by using the electronic voting system provided by Central Depository Services (India) Limited ("CDSL") by remote e-voting prior to as well as during the Meeting.
- The voting period for remote e-voting prior to the Meeting commenced on Friday, April 19, 2024 2. at 9:00 AM (IST) and ended on Sunday, April 21, 2024 at 5:00 PM (IST).
- AMNS Gandhidham had also provided remote e-voting facility to the unsecured creditors present at the Meeting through VC/OAVM and who had not cast their votes on resolution earlier by 3. availing the remote e-voting facility prior to the Meeting. The remote e-voting module was disabled by CDSL for voting 15 minutes after conclusion of the Meeting.

- 4. The voting rights of the unsecured creditors were in proportion to such unsecured creditors' outstanding value/amount (due to the unsecured creditors by AMNS Gandhidham) as on October 5, 2023 ("cut-off date") in compliance with the Order. Unsecured creditors of AMNS Gandhidham as on cut-off date were entitled to attend the Meeting (either in person or through an authorised representative under Section 113 of the Act) through VC/OAVM and vote through electronic means.
- As confirmed by AMNS Gandhidham, the notice dated March 20, 2024 along with the Scheme and explanatory statement under Section 230 (3) of the Act read with Rule 6 of the Rules and other annexures ("Notice") was sent to the unsecured creditors in relation to the resolution passed at the Meeting, in compliance with the Order, read with the Circular No. 17/2020 dated April 13, 2020; Circular No. 20/2020 dated May 5, 2020; Circular No. 22/2020 dated June 15, 2020; Circular No. 33/2020 dated September 28, 2020; Circular No. 39/2020 dated December 31, 2020; Circular No. 14/2020 dated April 8, 2020; General Circular No. 02/2022 dated May 5, 2022; General Circular No. 70/2022 dated December 28, 2022 and General Circular No. 09/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs and the Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India (SS-2).
- The Order directed that the quorum for the Meeting of the unsecured creditors will be 1 (one) unsecured creditor present and voting. As per the information provided by CDSL, 55 unsecured creditors attended the Meeting. Hence, the quorum was present throughout the Meeting.
- 7. The votes were unblocked on April 22, 2024 at 12:37:54 PM (IST) in the presence of the following two independent witnesses who are not in the employment of AMNS Gandhidham:

- 8. The management of AMNS Gandhidham is responsible to ensure the compliance with the requirements of the Act and the Rules, as applicable, relating to voting through remote e-voting and e-voting during the Meeting on the resolution mentioned in the Notice. AMNS Gandhidham had appointed an independent agency, CDSL to conduct this process of voting.
- Our responsibility as the Scrutinizer for the remote e-voting process is restricted to scrutinize the remote e-voting process and to prepare a consolidated Scrutinizer's Report of the votes cast "in favour" or "against" the Resolution and "invalid" votes, based on the reports generated from the remote e-voting system provided by CDSL. In view of the same, we have scrutinized the said process and votes tendered therein based on (i) the data downloaded from the CDSL e-voting system i.e. www.evotingindia.com; (ii) the list of unsecured debt as on the cut- off date provided by AMNS Gandhidham, in accordance with the Order; and (iii) the authorizations received from the unsecured creditors of AMNS Gandhidham.
