Once the vote on a resolution is cast by the members, the members shall not be allowed to change it subsequently. Notice is also hereby given that the Company has fixed Friday, September 20, 2024 as the Record Date for the purpose of identifying the members for the purpose of AGM who are entitled to vote on the Resolutions set forth in the Notice.
